## IMPORTANT ATTS NOTES FOR PARTICIPANTS IN THE TEMPERAMENT EVALUATION PROGRAM

- 1. The ATTS Temperament Evaluation measures the dog's strength of response to arrive at the temperament baseline.
- Dogs of at least 18 months of age, either pure-bred or neutered or spayed mixed-breeds, are eligible to participate.
   Non-neutered and non-spayed mixed-breeds may also participate but will not receive a certificate or a Temperament Title.
- Owners of eligible dogs, which pass the test requirements and are officially verified by ATTS, will be awarded an ATTS
  Temperament Title Certificate showing the dog's TT number with breed designation. This title may be listed after the dog's
  name.
- 4. The combined findings of the Chief Tester and the two Testers at the test are binding and final.
- 5. To promote uninfluenced, fair and uniform testing of all dogs, only one dog and one handler will be allowed in the test area during testing. Those who do not adhere to the ATTS Chief Tester's instructions may be denied participation without refund or may risk having their evaluation process canceled without refund.
- 6. In compliance with changes in ATTS regulations, male dogs and bitches are no longer required to be tested separately, but will be followed by bitches in season. Bitches in season should not be in or near the testing area prior to being tested.
- 7. Taking photos/videos is encouraged but must not interfere with the testing.
- 8. Smoking and consumption of alcoholic beverages are prohibited in the testing area.
- Dogs deemed unacceptable for testing for reasons of temperament (uncontrollable, overly aggressive, extremely fearful, etc.), health, poor appearance, handicap or advanced pregnancy may not participate.
- 10. A dog failing one or more of the ten subtests is considered as failing the evaluation. A subtest is failed when a dog shows unprovoked aggression, obvious avoidance, or panic without recovery; the test may be terminated immediately without refund. A dog may be retested after a five-month waiting period (full entry fee required).

I certify that I am the actual owner of this dog or that I am the duly authorized agent of the actual owner whose name I have entered on the reverse side of this form. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of the American Temperament Test Society and to accept the rulings of this organization or those working for this organization, and on completion of the activities, will accept the conditions of those in connection with this organization. I (we) further agree that the ATTS officials conducting this Evaluation have the right to refuse this entry for cause which ATTS shall deem sufficient.

I (we) certify that this dog entered is not a hazard to persons or other dogs, and I (we) further agree to accept full and complete responsibility for the actions of my (our) dog during the activities of this Evaluation. I (we) agree to hold the American Temperament Test Society (ATTS), its officials, officers, directors, members, advisers, agents, test participants, host organization, etc., and the owner or lessor of the premises and any employees of the aforementioned parties harmless from any and all claims for loss or injury which may be alleged to have been caused directly or indirectly to any person, property or thing by the act of this dog or any other dog(s) belonging to me, or which I have brought with me, while in or upon the test premises or grounds or near any entrance thereto, and I (we) shall personally assume all responsibility and liability for any such claim.

I (we) agree to hold the aforementioned parties harmless for any claims for loss or injury to this dog(s) by disappearance, theft, death, or otherwise and for any claim for damage or injury to the dog, whether such loss, disappearance, theft, damage or injury, etc. be caused or alleged to be caused by the negligence of ATTS, the host organization, or any of the aforementioned parties or by the negligence of any other person or any other cause or causes.

I (we) further agree to hold this organization, its officials, agents, employees of the aforementioned parties, and anyone working in and/or for this organization, as well as those working with or for a local, independent club and their dogs participating in any and all activities in connection with this organization harmless from any claim for loss, theft, damage or injury caused or alleged to be caused by the negligence of the organization or any of the parties aforementioned, or by the negligence of any other person, cause or causes.



From I-15, go east on E Vio Rancho Pkwy, R-Old Milky Way, L-Haverford Rd, L Lilac Rd, R-W. Pile St, L- Elm St

#### **Protocols**

- ATTS REQUIRES A SIX (6) FOOT LEASH & SLIP COLLAR, FOR SAFETY
- ATTS ALLOWS ONLY ONE DOG AND THEIR HANDLER ON THE TEST AREA AT A TIME.
- Keep your dogs safely secured in a crate, ex-pen or vehicle in the parking area, until you are called for your turn.
- Please observe testing quietly and avoid noise and movement that will interfere with the dog being tested. We may ask noisy
  conversations and such to move to the parking lot.
- Do not approach other dogs and people with your dogs, unless invited to do so.
- The Chief Tester is in charge of the test and test field. Her decisions are official.
- BRTCWest and the property owner, Denise Remtema, are in charge of the site, general safety and anything else not under the Chief Tester's span of control.
- The Event Secretary's decisions are official.

### **Site Safety**

- This is an open field, the ground is uneven. Watch your footing.
- This is a working ranch property. Do not approach wild animals or livestock with dogs, and only at your own risk.
- Dogs must be under your control at all times, or securely confined. No off leash, non-confined dogs are allowed during the
  event.

#### Dog Safety

- All dogs on site are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- There is water available at the field.
- Check for parasites like fleas and ticks when you prepare to leave or get home.
- Check your dog for weed heads like foxtails and other plant matter.
- Dogs cannot be left on the site without the owner/handler on site. Even if you leave for a very short time, you must have someone agree to watch over your animals.
- Make every effort to house your dog in a way that it cannot escape and create a hazardous situation.
- Do not leave your dog in a vehicle if the ambient temperature is above 68 degrees, plan ahead and bring shade for your crates and pens. All persons attending this dog show hereby waive any claim for damages against the Black Russian Terrier Club of the West, or its members, or the property owner, n the event a motor vehicle has to be entered to rescue a dog from overheating or having been placed in improperly vented conditions, or under apparent duress.

### Other Information

- There is a gazebo on the property, but please bring chairs for your comfort.
- There is an outhouse on property for humans.
- Please be respectful of the grounds we are borrowing. Clean up after your dogs and take your trash with you.
- This is very likely to be chilly and very breezy. Plan to stake your canopies. Bring layers of clothing.
